



Some Soapmaking Studio Classes are Taxable

According to the California Department of Tax and Fee Administration, some services are taxable, including some of our classes. This was the example presented to us by the CDTFA representative: If a man takes a pair of pants to an alterationist and asks for the pants to be hemmed an inch to match his exact height, then the service is not taxable because the man brought in a pair of pants and leaves with a (slightly shorter) pair of pants. However, if the man asks for the pants to be cut down to shorts, then the service is taxable because a new item has been created; the man now has new shorts.

As mandated by the CDTFA, if a new item is created during a class, then the class incurs California state sales tax at the current rate. If nothing is made or created during the course of the class, then the class is nontaxable. All materials for the class are taxable for students who attend the class in person.

Likewise, whether or not an online student is located in California, online classes are taxable if a new item is created during the class because the service (the live class) takes place within the state of California. For online students, the materials fee and the online fee (including shipping) to mail materials to the student are both nontaxable for students outside of California. For an online student within California, only the class fee (if a new item is created) and materials fee are taxable, the online fee and shipping are nontaxable.
